Position Summary: WOW Counselors are responsible for providing school- based group counseling and direct service to girls in 7th-12th grade to ensure they develop responsible decision-making skills, self-awareness, emotion management, self-acceptance, healthy relationships and social awareness. The WOW Counselor will use their clinical expertise and youth engagement skills to empower the girls to become successful in school and life.

Essential Duties/Responsibilities:

- Facilitate 4-5 weekly group counseling sessions utilizing the WOW curriculum during the school day
- Provide clinical assessments for each client
- Provide individual counseling for WOW students
- Provide family and crisis intervention as needed
- Perform weekly required documentation and special administrative assignments
- Participate in WOW staff development and required curriculum trainings
- Provide all necessary functions to develop the WOW program using teacher trainings and school in service presentations
- Collaborate with the LSC, Parent Programs and the Pupil Personnel Support team
- Participate on assigned WOW committees
- Serve on Youth Guidance Board and/or agency committees as requested
- Perform public relations assignments as requested
- Other duties assigned
